### 1. Funding opportunities

# i. The Canadian Institutes of Health Research (CIHR) Catalyst Grant : Health Services and Systems for an Aging Population

This is a strategic initiative of the Institute of Aging to address national research and knowledge exchange priorities associated with Health Services and Systems for an Aging Population (HSSAP). The objectives of the initiative are to develop and exchange knowledge that will inform health services and systems across the spectrum of care for older Canadians, from primary care to long-term care, home care and end-of-life care. The **registration** deadline is **June 15**, **2012** and the **application** deadline is **August 1**, **2012**. Complete details for this opportunity are available on <u>ResearchNet</u>.

### ii. Post-doctoral Fellowship

This opportunity is for a three-month Canadian Studies postdoctoral fellowship, with Trent or Carleton Universities as possible Canadian hosts. Funding proposals submitted recently:

# i. Aurea Foundation

The York University Division of Advancement contacted Tamara and Pat about submitting a Letter of Intent (LOI) to this foundation. An LOI on *Teaching "Care"*; *Personal Support Worker Training in Ontario*, was submitted February 14, and we are waiting to hear if the funder is interested and asks for a full proposal.

# ii. Canadian Institutes of Health Research (CIHR) Operating Grant: Winter 2012 Priority Announcement

Tamara Daly, with Pat Armstrong and Karen Messing, submitted a registration application for a project on *Invisible Women: Gender and the Shifting Division of Labour in Long-term Residential Care* to the specific research area, Gender, Work and Health. The full application is due March 1, 2012, and the decision is expected at the end of June.

# iii. Social Sciences and Humanities Research Council (SSHRC) Insight Development Grant February 2012 Competition

Annmarie Adams, with Sally Chivers and Tamara Daly, has submitted a proposal on *The Place of Aging: Designing Long-term Care Facilities in Canada* to this competition. Results are expected in June.

# Funding proposal updates:

# i. ERA-AGE 2 Joint Call for Research Applications (JCRA) on Active and Healthy Ageing Across the Life Course

On December 22, 2011 we were notified that our pre-proposal, submitted in October in partnership with the UK (Liz Lloyd), Sweden (Marta Szebehely) and Norway (Mia Vabø), was successful! We're currently working to submit the full application for our project on Healthy Aging in Residential Places (HARP) by March 16, 2012. Team members will be included as an "advisory" group. A decision is expected by October 2012 at the latest.

# ii. Ontario Research Fund – Research Excellence (ORF-RE) Funding, Social Sciences, Arts and Humanities Round

The Ontario government cancelled this call due to "fiscal challenges". We had submitted a Notice of Intent to develop a proposal entitled *Re-imagining Long-term Care: Promising Practices in Ontario*.

# iii. Canadian Institutes of Health Research (CIHR) Operating Grant: Advancing Theoretical and Methodological Innovations (2011)

A decision on our application to this grant — *Developing an Integrated, Multidisciplinary Conceptual Framework for Health Services* - is expected at the end of March 2012.

The York Seminar for Advanced Research series continues through the winter semester.
